Code Enforcement Officer (CEO) – Report Submitted

<u>Sexton/Cemeteries</u> – Discussion on Webster Cemetery (off Rt.100) Dean Cray questioned why funds were being raised privately and not paid for by the Town. The Fosses along with volunteers have taken on this project and want to do what they can but will probably need assistance to put up a fence. Access to cemetery is now through a private driveway and not an issue with land owner. At some point the right of way should be opened up and made usable.

Administrative Assistant/Treasurer – Isaac Sargent needs to have his driveway culvert replaced. This is the Town's responsibility. There are culverts at the Garage.
