Reports:

<u>Public Works</u> – Corey has prepared a slide show of culverts that need replacing. The Gate at the Town Garage has been repaired and the yard cleaned up. Ditching is done. Culvert at Route 2 end of the Square Road needs replacing, the State will supply the culvert if we do the work. (State does not have time right now). Hope Road culvert is in bad shape also. Would like to build a shelter for winter sand for residents. Approximate cost is around \$300.

Planning Board – Minutes submitted. Gail updated the Board, Sign permit has been approved for Home Town Health, Kirtas Jandreau plans to submit a new application for a Used Car Business on Main Street. Administrative Assistant/Treasurer - Treasurers Statement submitted. Have had more complaints of speeding on Lang Hill. Mike has spoken to Sheriff Department trying to get some enforcement. Also have had complaint concerning speed on the Michaud Road. Someone is interested in the Stair Unit in the Gym area. Is sitting outside out of the way right now. Have received the Survey for the property to be donated to the Town. Waiting on wording for Deeds to send to our Attorney to prepare for transfer to the Town and sale of a portion.

Other Committees – Park Boosters would like to install electric lights in the Park instead of solar and replace lights for the memorial. Would provide better lighting and new lights are more efficient. Around \$1900 was realized from the yard sale.

The Veterans Committee is going to provide funds to clean more cemetery stones this fall.
