TOWN OF PALMYRA

To Diane White, resident of Palmyra in said county,

Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of Palmyra, qualified to vote in town affairs, to assemble at the Palmyra Community Center in Palmyra on Friday the 7th day of March, A.D. 2025 at 7:45 a.m., then and there to act on Articles One and Two, to then adjourn and reassemble at the Palmyra Community Center on Saturday the 8th day of March, A.D. 2025 at ten o'clock in the forenoon then and there to act on the remaining articles to wit:

Note: Election of Moderator will be at 7:45 a.m. and voting will be from 8:00 a.m. to 7:00 p.m. on Friday March 7, 2025.

Art. 1 To elect a moderator by secret ballot to preside at said meeting.

Art. 2 To elect the following by secret ballot:
Selectperson, Assessor and Overseer of the Poor
- Two members for three year terms.
RSU Director
- One member for a three year term.

Art. 3 To see if the Town will vote to raise and appropriate \$11,865 for Select Board member's compensation.

Art. 4 To see if the town will vote to raise and appropriate \$63,100 for insurances, estimated breakdown as follows:

Health	40,000.00
Property & Casualty	18,500.00
Workers comp	3,000.00
Unemployment	<u>1,600.00</u>
Total	\$ 63,100.00

Art. 5 To see if the Town will vote to raise and appropriate \$166,000 for the Town Charge Account.

Estimated expenditures as follows:

A. Compensation	\$108,000
B. Contract Services	42,000
C. Utilities	5,000
D. Supplies/Fees	6,000
<u>E. Lien Costs</u>	<u>5,000</u>

- Art. 6 To see if the Town will vote to raise and appropriate \$60,000 to maintain the Community Center. Estimated expenditures as follows:

- Art. 7 To see if the Town will vote to raise and appropriate \$5,000 for utilities and maintenance for the Town Hall and Modular Building.
- Art. 8 To see if the Town will vote to raise and appropriate \$7,500 for assessing work.
- Art. 9 To see if the Town will vote to raise and appropriate \$19,500 for Code Enforcement and appropriate Plumbing Fees to this account.
- Art. 10 To see if the Town will vote to raise and appropriate \$23,000 for a sexton and for maintenance of the town cemeteries. Interest earned from the Cemetery Investment account in 2024 to be credited to this account. Also to authorize the Select Board to enter into or continue contracts for cemetery maintenance and sexton.
- Art. 11 To see if the Town will vote to raise and appropriate \$2,000 for cleaning and repair to cemetery stones.
- Art. 12 To see if the Town will vote to accept a gift of land to extend the Village Cemetery and have public access to Whites Pond and to raise and appropriate \$3000 for survey and legal work needed to acquire said property.
- Art. 13 To see if the Town will vote to raise and appropriate \$5,000 for General Assistance and appropriate funds reimbursed from the State of Maine.
- Art. 14 To see if the Town will vote to raise and appropriate \$4,000 for Maine Municipal Association dues.
- Art. 15 To see if the Town will vote to raise and appropriate \$250 for membership in the Sebasticook Valley Chamber of Commerce.
- Art. 16 To see if the Town will vote to raise and appropriate \$1500 to purchase flags to display on Main Street.

Art. 17 To see if the Town will vote to raise and appropriate \$119,237 for the fifth payment of funds borrowed for paving.

Note: This is the fifth and final payment due under a note executed by the Select Board on behalf of the Town and authorized by a vote of Town meeting on March 13, 2020.

Art. 18 To see if the Town will vote to raise and appropriate \$200,000 for the Public Works account. Estimated amounts in each category as follows:

Winter Roads	60,000
Capital Road Improvements	50,000
Equipment/Garage	<u>75,000</u>
Total	\$200,000

Art. 19 To see if the Town will vote to raise and appropriate \$184,870 for the third payment of funds borrowed for paving.

Note: This is the third and final payment due under a note executed by the Select Board on behalf of the Town and authorized by a vote of Town meeting on March 12, 2022.

Art. 20 To see if the town will vote to raise and appropriate \$71,000 for Fire Protection and to authorize the Select Board to continue/enter into contracts for this purpose.

Art. 21 To see if the Town will vote to raise and appropriate \$180,000 for Solid Waste Disposal, and appropriate reimbursements from Municipal Review Committee (MRC).

Art. 22 To see if the Town will vote to raise and appropriate \$3,000 for recycling.

Art. 23 To see if the town will vote to raise and appropriate \$5,000 for legal expenses. This would include expenses associated with the sale of tax-acquired property, land-use violations and other legal expenses. Any fines and reimbursements will be credited to this account.

Art. 24 To see if the town will vote to raise and appropriate \$3,000 for the Planning Board and Board of Appeals.

Art. 25 To see if the Town will vote to raise and appropriate \$8,000 for the Animal Control account and appropriate Dog License Fees to this account.

Art. 26 To see if the Town will vote to raise and appropriate \$1,000 for mileage and expenses for the Emergency Management Director and the Health Officer.

Art. 27 To see if the Town will vote to raise and appropriate \$5,500 for the Recreation Program.

- Art. 28 To see if the Town will vote to raise and appropriate \$5,000 for maintenance of the Town Park and to authorize the Select Board to continue/enter into contracts for this purpose.
- Art. 29 To see if the Town will vote to raise and appropriate \$1,000 for the Palmyra Scholarship Fund.
- Art. 30 To see if the Town will vote to raise and appropriate \$3,500 for library services.
- Art. 31 To see if the Town will vote to give the revenue received from Inland Fisheries & Wildlife for snowmobile registrations to the Palmyra Snowmobile Club.
- Art. 32 To see if the Town will vote to raise and appropriate \$2,854 for dues for Kennebec Valley Council of Governments (KVCOG).
- Art. 33 To see if the Town will vote to raise and appropriate \$10,000 for the Capital Improvements investment account.
- Art. 34 To see if the Town will vote to raise and appropriate \$6,000 for restoration of vital records.
- Art. 35 To see if the Town will vote to appropriate \$54,000 from the LRA account for paving.
- Art. 36 To see if the town will vote to appropriate \$11,500 from the Capital Improvements account for repair to the Community Center heating system.
- Art. 37 To see if the Town will vote to raise and appropriate \$25,000 for repairs to the Community Center parking lot.
- Art. 38 To see if the Town will vote to charge residents for the use of classrooms at the Community Center at a discounted rate.
- Art. 39 To see if the Town will vote to take \$3280.46 from surplus and \$5363.20 from the Assessing Investment Account to ratify overdrafts in fiscal year 2024 (Town Charges - 3030.44, Library - 231.90, Paving Loan - 18.12, Legal - 5363.20)
- Art. 40 To see if the Town will vote to charge interest on all unpaid taxes after such date the Town shall determine, and set rate.
- Note - maximum allowed by the State Treasurer is 7.5 percent.
Select Board recommends 4 percent to start 60 days from day of commitment.*
- Art. 41 To see if the town will vote to authorize the tax collector or treasurer to accept Pre-payments for taxes not yet committed, pursuant to 36 M.R.S.A. §506.

- Art. 42 To see if the Town will vote to authorize funds for Abatements to come from overlay.
- Art. 43 To see if the Town will vote to raise and appropriate \$14,507 for the following:

Palmyra Soup Kitchen – \$2,000
Newport Food Bank – \$1,000
Winslow Community Cupboard - \$2000
KVCAP Transportation Program - \$500

- Art. 44 To see if the Town will vote to have the Select Board choose all necessary Town Officials for the ensuing year and fix compensation for same.
- Art. 45 To see if the Town will vote to authorize the Select Board to spend an amount not to exceed three-twelfths (1/4) of the budgeted amount in each budget category of the 2025 annual budget during the period from January 1, 2026 to the Annual Town Meeting.
- Art. 46 To see if the Town will vote to authorize the Select Board to obtain loan(s) in anticipation of taxes not to exceed fifty percent (50%) of the total commitment, such loans to be paid during the current fiscal year.
- Art. 47 To see if the Town will vote to authorize the Select Board to sell and dispose of any real estate acquired by the Town for non-payment of taxes, in such terms as they deem advisable, and to execute quit-claim deeds for such property. And if they should choose to employ a bid process, the Select Board has the right to accept or reject any or all bids. Notices of tax acquired property sales will be posted in a newspaper that covers the local area.

- Art. 48 To see if the Town will vote to authorize the Select Board to sell excess Town equipment and property and credit funds realized to Public Works account.
- Art. 49 To see if the Town will vote to place the balance of the Veterans' Memorial fund in an investment account for future expansion of the Memorial and to authorize the Town to accept funds from individuals for the purchase of paving stones. These stones will be placed near the Veterans' Memorial to honor individuals chosen by the purchaser.
- Art. 50 To see if the Town will vote to continue the fund for the purpose of accepting donations for Palmyra's Christmas program known as the Giving Tree with any funds remaining in the account at the end of the year to be carried over to the next fiscal year.
- Art. 51 Shall the Town of Palmyra vote to authorize the Select Board to accept or reject grants, donations, and or gifts of money to the various accounts of the Town of Palmyra for FY2025 and to expend monies donated for specific purposes.
- Art. 52 To see what sum the Town will vote to authorize the Select Board to take from anticipated revenue and surplus to lower the 2025 Tax Commitment.
